MESSAGE FROM THE PRESIDENT - DAVID SHERRY

Some comments made at recent OILA meetings showed how little many people know about OILA online resources for members and how OILA recordkeeping has improved starting 18 months ago. Here is a rundown:

OILA Records (Correspondence) – OILA's Records Custodian is Secretary John Donovan.

Immediately after his election in June 2019, John created and has maintained electronic archives in a dedicated email account. Electronic storage is password protected, filed, and preserved for transfer to the next board Secretary and use by the next board. These records include correspondence sent by the OILA President as directed by the membership to Okaloosa County. John has maintained OILA paper records created since his election. Some historical records are stored at the Okaloosa Island Fire House, while others are also

<u>ARC Records</u> – OILA's Architectural Review Committee ("ARC") now keeps its records on its dedicated email account, <u>OilaArc@yahoo.com</u>, which will stay with the committee as ARC membership turns over. The ARC reviews proposed projects for compliance with the Okaloosa Island Protective Covenants and Restrictions. Approval of the ARC is required for projects which require an Okaloosa County permit. You can reach the ARC at <u>OilaAarc@yahoo.com</u>. Projects brought before the ARC are listed in the OIL Lantern.

<u>OILA website</u> – OILA has maintained a website, <u>www.oilaweb.com</u>, since 2005. On it you can find newsletters, meeting minutes, treasurer reports, official OILA positions on issues, ARC information, meeting podcasts, beach and bridge information, OILA directors, and key documents such as the Island Covenants and OILA's By-Laws, etc. In the top left hand corner is a "Contact Us" button, which you can use to send an e-mail to <u>webmaster@oilaweb.com</u>. The OILA website consistently receives about 75 visitors daily. After long time webmaster Bob Seitz retired, OILA President David Sherry assumed webmaster duties.

<u>Facebook</u> – OILA has a facebook page, https://www.facebook.com/pages/category/Community-Organization/Okaloosa-Island-Leaseholders-Association-OILA-541206789267225/. There is also a link to the facebook page on the OILA website. The facebook page has 294 likes and 330 followers. OILA member Cynthia Henderson is the moderator.

<u>Newsletter</u> – OILA's newsletter, the OIL Lantern, is assembled and distributed by long time OILA Newsletter Editor, Jim Simpson. Each OIL Lantern contains information on how to contact the OILA board members and Editor Jim Simpson, meeting minutes, treasurer's reports, the Architectural Review Committee Reports, and much more.

<u>OILA Records (Membership)</u> – OILA's Treasurer is Jim Simpson. He also maintains the OILA membership list. OILA correspondence comes from his e-mail, <u>sanleanna@cox.net</u>.

<u>Member Privacy</u> — Your contact information is not shared with the OILA board, other members, or outside parties. If you request anonymity in a contact to the OILA board, we have and will work with you one on one to maintain your privacy. In order to resolve some issues you may have to make a decision whether to disclose your contact information to regulators or authorities, if your issue cannot be worked out anonymously.

Please remember that everyone doing the above jobs is a volunteer. Some issues require research so an immediate response is not always possible. Okaloosa Island is our home too.

<u>Bridge Update</u> – FDOT updated us with some good news. Previously, FDOT needed to re-configure the new bridge tie-ins at Santa Rosa Blvd. and U.S. Hwy 98 due to difficulty acquiring Air Force land at the southeast corner of the intersection. After more discussion and evaluation of the traffic operation drawbacks when avoiding the Air Force land, the parties involved have figured out a way to expedite agreements and get to a solution so that the original approved concept is being carried forward. This is a good thing for traffic flow.

<u>Dune Planting Update</u> – Volunteer dune planting is getting closer. Okaloosa County has its permit and is arranging to purchase 300,000 sea oats for Okaloosa Island. We should get a few weeks notice before the sea oats arrive, and then we will send out a call for volunteers.



In 2012 Okaloosa Islanders and friends planted the Okaloosa Island dunes with sea oats. We hope you can join us for the 2021 dune planting with Okaloosa County. – David Sherry

There were no injuries. The cause of the fire is not known and is being investigated by the State Fire Marshal and the Florida Fish and Wildlife Commission.








