### **MESSAGE FROM THE PRESIDENT – DAVID SHERRY**

More Snorkel Reefs Coming To Okaloosa Island – You may have noticed a strange looking vessel working about 400 feet offshore near the 6<sup>th</sup> Beach Freeway (see photo below). The vessel is deploying snorkel reefs for Okaloosa County. Once these reefs are in place near the 6<sup>th</sup> Beach Freeway, the vessel will move to the 2<sup>nd</sup> Beach Freeway and install reefs there too. The County previously placed similar reefs at the 4<sup>th</sup> Beach Freeway and near Beasley Park on Okaloosa Island. This will finish the project for Okaloosa Island. The County deployed / is deploying similar reefs in Destin.



<u>Dune Planting Update</u> – Volunteers are needed to help plant sea oats and panic grass on the dunes on Okaloosa Island (see photo below). <u>Okaloosa County has moved back its *estimated* starting date for dune planting to no <u>sooner than Saturday, April 24</u>. The project has been delayed due to Covid-19 related shortages. The County now has the sand fence but is still waiting for the poles to anchor them in place. Dune plants won't be added to a section of dune until after the sand fence is installed there. Please contact OILA President David Sherry if you would like to volunteer to help plant the dunes. If you have a location preference for where you want to plant, please include that information. As with the beach clean-ups, volunteers will need to sign a liability waiver. Volunteers should wear comfortable clothing and shoes. More details will follow as the date draws closer.</u>

(Editor's Note: The use of the interactive map is an excellent method to use to report outages. Zoom in on the Okaloosa Island part of the map several times until you reach the view which shows the green street light icons is displayed. These icons identify the location of the streetlights. Click on the icon which needs repair and the pole will be automatically identified by Light ID and Pole Tag Number; then click on "Report It". Job done!) You can also find this site by searching on "Gulf Power report street light outage" with your favorite search engine. Whatever method of notification you use, give your name, contact information, the malfunction of the light, and the specific location. A pole number is very helpful if available. Also, state that the light is paid by the Okaloosa Island MSBU. This ensures that repair orders are issued from the correct account.

**REMEMBER**: Our MSBU dollars pay for the streetlights whether they are lit or not, and Gulf Power fixes lights that are out at no additional charge.



#### **OBSERVATIONS AND COMMENTS FROM OILA DIRECTOR, BRICK BRADFORD**

Neighbors,

At the 19 Jan 2021 BCC meeting, the director of Public Works for Okaloosa County Jason Autrey briefed the County with the purpose of requesting \$100,000.00 to support an expanded artistic Rendering of the entire length of Santa Rosa BLVD (SRB). His goal is to provide an overarching graphic view of each intersection along SRB to provide Island residents with various alternatives noting that one approach may not necessarily work best at all intersections.



There were two issues discussed during the BCC meeting that I found disturbing. First was Commissioner Ketchel stating that whatever is finally determined regarding any improvements along SRB, she wants both public parking and storm water addressed. While addressing the habitual flooding along SRB is a necessary endeavor and I applaud our Commissioner's support for stormwater improvement, I believe there are alternative options for increasing public access to our beaches without desecrating our Northside Freeways. The second issue were comments made by Mr. Autrey and Commissioner Boyles regarding the need for four lanes along SRB. Mr. Autrey explained that current traffic counts do not substantiate four lanes. Commissioner Boyles also stated that he did not see a need for four lanes all the way to the end of SRB and newly elected Commissioner Paul Mixon agreed.

I met with Commissioner Ketchel and Mr. Autrey on 3 Feb to further discuss the vision and options for improving SRB. We discussed the issues above and much to her credit, Commissioner Ketchel unequivocally stated that SRB will remain four lanes because that is what her constituents want! I also encouraged Commissioner Ketchel to consider alternative options for public parking. I specifically cited our Protective Covenants and Restrictions regarding the limitations cited therein for our Northside Freeways. Mr. Autrey agreed that the County would only gain no more than an additional 120 public parking spaces if they were to proceed to pave all our Northside Freeways. I suggested alternative public transportation strategies could include a Water Taxi from the Brooks Street Landing, Marler Park, and perhaps create a public access point at Northside Freeway access 1 as it is zoned accordingly. We also talked about public beach bus transportation that could connect visitors from their hotels along HWY 98 and various points on Okaloosa Island.

The timeline for initiating and completing the scope of work for improving SRB was also considered. Mr. Autrey noted that FDOT's schedule for replacing the Brooks Bridge is ahead of where the County is now for making and completing improvements on SRB. This means that it may be **at least six more years** before we see any tangible improvements along SRB. Citing the ongoing flooding that occurs along SRB and the horrible state of our sidewalks, I asked if were possible to begin improving drainage and the existing sidewalk as soon as possible.

Mr. Autrey explained that depending on what work is decided for SRB, it is possible that work could end either before or after the Brooks Bridge project. He also remained hopeful that once a vision is developed, we could find ways to incorporate projects along the SRB corridor sooner than the forecasted timeline. We also discussed improving our Beach Access Crosswalks with Flashing Signals. Unfortunately, Mr. Autrey suggested that studies show flashing signals do not offer any meaningful improvement to increase awareness. I disagree. My bride and I travel the downtown corridor almost twice daily and those visual aids work. If you are concerned over timelines or increasing the visual awareness of our crosswalks, I encourage you to communicate with our County Commissioner.

- President Sherry stated the Okaloosa County volunteer dune planting will *tentatively* be held around Saturday, April 3. He thanked everyone who has volunteered, requested additional volunteers and asked those interested in planting to contact him.
- President Sherry stated FDOT ("Florida Department of Transportation") will hold a virtual Brooks Bridge aesthetics workshop on March 18, with public comments due by April 8. He praised FDOT for their willingness to listen and to incorporate public input into past designs. He said he will ask Treasurer Jim Simpson to send an e-mail blast to the membership closer to the date.
- Director Brick Bradford stated he has seen the Okaloosa Island master plan but does not have a copy. Brick agreed to send Secretary John Donovan a screen shot of the front page. John has previously researched Okaloosa Island historical records for OILA.
- Kathy Foster stated Paula Hudson and she have reported 26 lights out on Okaloosa Island. President Sherry thanked Kathy and Paula for reporting the outages. David said he has found the Gulf Power website makes it easy for him to report outages, and that users can pull up a map and click on a light to get it fixed.

The meeting was adjourned at 7:15 PM (motion by Rebecca Sherry, seconded by Secretary John Donovan and passed 12-1 (Dave Hancock opposed).
