

A "THANK YOU" MESSAGE FROM OILA MEMBER BRIAN SMITH (Editor's note: Brian resigned from the OILA Board of Directors effective October 2, 2022)

I would like to thank you for the opportunity to serve the Okaloosa Island Board of Directors. Having been voted into the position with 191 OILA member votes, I want to personally thank you for your vote and let you and the OILA membership know the reasons for my resignation.

In addition to being happily married to my soul mate, Lesa, with our 8 children and 9 grandchildren, I am currently working full time on Eglin AFB.

Prior to being elected I did not realize the almost full-time service commitment required by the OILA Board of Directors. My time on the Board was primarily consumed with learning more about the Santa Rosa Blvd Improvement Project, meeting with the Board of County Commissioners and Engineering Staff, reviewing BCC SRB Improvement plans, and restating the OILA membership position of keeping all four driving lanes.

The positions that I ran on which are still of concern: (1) Sand dredged from East Pass should go toward Okaloosa Island,

- (2) The Covenants should not be changed without majority approval of Okaloosa Islanders,
- (3) The north side accessways should stay natural,
- (4) Any beach restoration should be with East Pass quality sand or better, and
- (5) Santa Rosa Blvd Improvement project keeping all 4 driving lanes.

In addition, the OILA Architectural Review Committee (ARC) work that I had been supporting for the last two years, has in itself at times been a full-time job, reviewing architectural drawings, verifying the projects adhere to the OILA Covenants, attending BCC meetings to provide OILA ARC inputs for projects that are in dispute.

Thanks to my mentors on the OILA BOD, Mr. Ed Henderson and Mr. Jack Pous, for their guidance and support. In addition, thanks to my colleague, Mr. Nick Hall, on the OILA ARC for all his hard work.

Maybe someday when I retire, I will have time to serve and support the OILA Membership on the ARC and the BOD if asked.

#### THIS MONTH IN HISTORY: DECEMBER

**December 1, 1990** - England was connected to mainland Europe for the first time since the Ice Age as engineers digging a railway tunnel under the English Channel broke through the last rock layer.

**December 2, 1982** - Barney Clark receives the world's first artificial heart transplant.

**December 2, 1942** - Physicists led by Enrico Fermi carried out the world's first successful nuclear chain reaction at the University of Chicago.



**December 5, 1933** - The 18th Amendment (Prohibition Amendment) to the U.S. Constitution was repealed. For nearly 14 years, since January 29, 1920, it had outlawed the manufacture, transportation, and sale of alcoholic beverages in the U.S.

**December 11, 1901** - The first transatlantic radio signal was transmitted by Guglielmo Marconi from Cornwall, England, to St. John's, Newfoundland.



**December 11, 1941** - A major turning point in World War II occurred as Japan's Axis partners, Italy and Germany, both declared war on the United States. The U.S Congress immediately declared war on them.

**December 13, 1928** - The Clip-on tie is created.

**December 16, 1944**: The Battle of the Bulge during World War II began as German forces launched a surprise counterattack against Allied forces at Ardennes Belgium. #### OKALOOSA ISLAND FIRE DEPARTMENT PROVIDES ASSISTANCE TO HURRICANE IAN VICTIMS - By Fire Chief Ray Strawn

The Okaloosa Island Fire Department (OIFD) played an important role in response to Hurricane Ian. Engine Strike Team 1101 (EST-1101), which consisted of five 4-man engines, deployed September 28<sup>th</sup> and was led by Okaloosa Island Captain Greg Lloyd. Captain Mike Simmons and Engineer Corey Crawford were also part of this

strike team, manning an Engine within the team. Assistant Uniet Sean Mast stepped in as the

Okaloosa County Region 1 coordinator for the first part of the deployment, organizing the crews and teams throughout the County with the State Emergency Operations Center. Assistant Chief Mast organized for the return of EST 1101

and organized an additional 5 Engine Strike Team (EST-1102) that depart October 6<sup>th</sup>. The relief Crews spent 14days in South Florida assisting those in need. Staffing an Engine on this strike team was OIFD's Captain Doug Brown and Firefighter Griff Ushe.

The missions scope varied widely during the deployment on Pine Island and Captiva Island. This included rescuing trapped victims, debris removal, fire suppression, and fire station relief of the local fire departments. The crews use boats, Humvees, and barges to move personnel and equipment to the islands and endured several weather conditions daily.

Later in the deployment Assistant Chief Mast was assigned Strike Team Leader for 1103. With his team of 5 Engines and 2 Tenders his crews assisted with all emergencies on Sanibel Island and Captiva Island for 14 days. While not handling emergencies, crews secured over 1300 residences for gas leaks and checked over 1400 Fire Hydrants. This experience gained by the crews of OIFD is invaluable; something that can't be learned in a classroom. The knowledge, experience, and lessons learned have been brought back to Okaloosa Island and plans are already being worked on to better

prepare Okaloosa Island should the need arise. Another important part of sending crews to the hurricane is the reciprocation that will occur if a similar event ever occurs on Okaloosa Island. This exchange of assistance was proven as the strike teams aided the Naples Fire Department; a department that suffered catastrophic flooding of their fire station. At another recent disaster, the Panama City Wildfires, crews from the Naples Fire Department were here assisting our local fire departments in a time of need.
