

YOU CAN'T KNOW A MAN BY JUST LOOKING AT HIS BASEBALL CARD -- THE AMAZING LIFE OF CATCHER MORRIS (MOE) BERG

Although Moe Berg played with five majorleague teams from 1923 to 1939, he was a very mediocre ball player. Yet, he spoke 15 languages and graduated magna cum laude from Princeton and from Columbia Law School. Following is the list of the fifteen (15) languages he spoke: Latin, Greek, French, Spanish, Italian, German, Sanskrit, Japanese, Chinese, Korean, Indian, Arabic, Portuguese and Hungarian.

Why did 3rd stinger Moe Berg accompany Babe Ruth on a trip to baseball crazy Japan in 1934? Simple answer: He was a U.S. spy working with the Office of Strategic Services (predecessor to the CIA). While in Tokyo, dressed in a kimono and sandals, he gained access (he spoke Japanese) to the tallest building in the city and photographed strategic areas. This information was later used by Jimmy Doolittle to identify targets for his attack on Tokyo. He infiltrated a meeting being held in December 1944 in neutral Switzerland to listen to a lecture by German physicist Werner Heisenberg who was leading the Nazi effort to build an atomic bomb. He talked to Heisenberg and determined that the Germans were nowhere near achieving a bomb (in fact, many believe that Heisenberg secretly sabotaged the German effort) and he accordingly advised Churchill and FDR. FDR replied to the information by saying "Give my regards to the catcher." Bottom line: Moe Berg was much more than a baseball card. But then, his card is on display at CIA Headquarters in New York City.

DRAFT MINUTES - OKALOOSA ISLAND LEASEHOLDERS ASSOCIATION - January 9, 2023 Membership Meeting

CALL TO ORDER: Hybrid in-person and Zoom meeting called to order at 7:00 PM by President Ed Henderson at the Okaloosa Island Firehouse with Secretary John Donovan moderating via Zoom.

PLEDGE OF ALLEGIANCE: Director Cynthia Henderson led the Pledge of Allegiance.

- I. ROLL: Board Members Present: Ed Henderson (President), Dr. Frank Adcock, Louis Belanger, David Jones, Jack Pous and Jesse Hunt. President Ed Henderson announced the presence of a quorum.
- **II. MINUTES:** Secretary John Donovan made a motion, seconded by Frank Adcock, to approve the draft November 14, 2022 Membership Meeting Minutes. The Motion to approve the November 14, 2022 Minutes was passed unanimously

III. TREASURER'S REPORT: Please see Attachment 1 for the full Treasurer's Report, presented by President Ed Henderson in the absence of Treasurer Jim Simpson. David Sherry moved to approve the Treasurer's Report and to reimburse Jim Simpson for his Treasurer's expenses, which was seconded by Jack Pous and unanimously adopted. In order to correct the \$200.00 Island Christmas Decorations Budget adopted at the November 14, 2022, Membership Meeting, to the actual Budget of \$400.00, a motion was made by David Jones, seconded by Barbara Secondi and unanimously adopted.

IV. JIM SIMPSON PROGRAMS AT CHRISTMAS: Christmas Food Drive and Firefighters' Foster Child Shopping Trip: The Members were informed that the Food Drive was an all-time record.

V. NANCY HUNT ISLAND RESIDENCE CHRISTMAS DECORATIONS PROGRAMS: Triangle/Median Display, Fundraiser and Awards: Nancy Hunt advised the members that the 2022 Christmas Decorations Program went very well. Nancy Hunt advised the Membership she had no idea who would cover this Program at Christmas 2023.

VI. COMMITTEE REPORTS: Standing Committees Architectural Committee Report: ARC members Nick Hall and Brian Harrington summarized the ARC Report from the OIL Lantern. There was a discussion led by David Sherry clarifying that OILA cannot decide anything regarding exceptions to enforcement of the Protective Covenants and Restrictions (PCRs), but neighboring Leaseholders/Owners can. David Sherry further mentioned that the ARC can't issue approvals for two story structures in the section of the Island zoned for single family residences, but the Board of County Commissioners (BCC) can.

VII. NEW AND UNFINISHED BUSINESS: Short Term Rentals in the Island's B1 Zone; The Relationship Between OILA and Okaloosa County; The Status of the Island's Protective Covenants and Restrictions; And the Okaloosa County Lane Reduction Plan For Santa Rosa Boulevard: President Ed Henderson introduced Director Jack Pous, who led a membership discussion of where OILA stands with respect to the above complex of issues. Jack Pous stated that the BCC does not regard OILA or the PCRs favorably, but the BCC does concede that the PCRs' prohibition on Short Term Rentals in the section of the Island zoned for single family residences, is valid. Jack Pous then turned to a discussion of the "Mike Mitchell Tape" referenced by Commissioner Carolyn Ketchel as relevant to the PCRs, at the end of a recent BCC Meeting. Mike Mitchell was a well-known long-time Island resident and former BCC member. Jack Pous, after submitting a Open Records Request, got a recorded copy of that Tape, which basically was Carolyn Ketchel interviewing Mike Mitchell in the presence of Greg Kisela, then a County administrator, with an unknown female, possibly an attorney, present. The Tape turned out to be more a sounding board for Commissioner Ketchel, as she predicted big changes coming to the Island, triggered by high developer interest in the Island, over the next 5 to 10 years. Brick Bradford stated that he believed the Tape was recorded in early 2021. This led to a discussion of OILA possibly obtaining legal representation, including the expected legal fees, and the possibility of increasing OILA voting member dues in order to build up a sufficient "war chest" to cover those legal fees. Brick Bradford warned that paving of all Northside Accessways, in contravention of specific provisions of the PCRs, is at the planning stage at the BCC, and is another risk that OILA needs legal advice on. The risk of OILA perhaps not having legal standing to pursue these remedies in court, was another topic on which OILA needed legal advice. Frank Adcock advised the members that raising the money by increasing dues would take a long time, and we don't have that kind of time. Jesse Hunt discussed the dues remaining at \$12 per voting member all this time, had ignored inflation, and Jesse's calculations suggested the possibility of increasing annual dues to \$120 per voting member. The conclusion of several members, led by Frank Adcock, was that dues increases would not get us there in time, and a member education program, in the hopes of locating "sugar daddies to help cover legal fees, and dramatically increasing membership so that the BCC would pay more attention to OILA. The possible cost of an Island property owner education program was then presented by Louis Belanger. There were about 4500 parcels of property on Okaloosa Island, but OILA had at most 275 voting members. The County tax database has the names and addresses of all those parcel owners, and it would not be very expensive to send an educational card to all those parcel owners. Concern over the BCC working with developers to ignore the PCRs; acquire parcels north of Santa Rosa Boulevard; and turn those parcels into condominiums so that the north side looked like the south side, and bed tax collections from Okaloosa Island would compete with Destin bed tax collections. David Sherry brought up OILA v. Hayes, a court case where it was held that the BCC did not have the power to modify the covenants. The BCC may have engaged counsel to try to find a way around the PCRs, but David Sherry expressed that he had no idea how an attorney could get around that

case. Jack Pous stated that it would be better to be prepared with OILA's own attorney, so we aren't fighting from behind. John Donovan suggested to the Members that while he did not disagree with Jesse's, Brick's and Frank's (Draft Minutes, January 9, 2023 Membership Meeting Continued)

warnings, but still the BCC had taken no position against the validity of the PCRs, so that as of yet John Donovan could not see an issue on which the BCC could be challenged by OILA. The exception to that could the BCC's position in support of the Lane Reduction Plan despite the PCRs' prohibition against restricting access to the Brooks Bridge. John Donovan concluded by advising that "sugar daddies" would likely be hard to come by, as, despite an extensive search for help with legal fees, we could not find any "sugar daddies" to join the Sherrys and myself when we did battle in support of Gulf Beach sand quality over 10 years ago. Next, there was an extended discussion of possible OILA access to the approximately \$300,000 in the Island's Street Lighting MSBU Fund for legal fees. Paula Hudson confirmed the amount. David Sherry advised the Members that the BCCs' consent would be necessary to disburse the funds in the MSBU, and he was pretty certain that the BCC would not consent to using the Fund to pay counsel to sue the County.

VIII. ANNOUNCEMENTS: None.

IX. ADJOURNMENT: Ed Henderson made a motion, seconded by Brick Bradford to adjourn the meeting at 8:30 PM, which motion was unanimously adopted by those members still present. John S. Donovan OILA Secretary

THIS MONTH IN HISTORY - APRIL

April 2, 1513 – Spanish explorer Ponce De Leon sighted Florida and claimed it for the Spanish Crown after landing at the site of present-day St. Augustine, now the oldest city in the continental U.S.

April 4, 1818: Congress adopted a U.S. flag with one star for each state.

April 18, 1942 - The first air raid on mainland Japan during World War II occurred as Gen. James Doolittle led a squadron of B-25 bombers taking off from the carrier Hornet to bomb Tokyo and three other cities. Damage was minimal, but the raid boosted Allied morale following years of unchecked Japanese military advances. *(Editor's Note: Doolittle's crews secretly trained in making short take-offs at Eglin Field for two weeks --March 9-25, 1942)*

April 23, 1791 - James Buchanan (1791-1868) the 15th U.S. President and only life-long bachelor to occupy the White House was born in Cove Gap, Pennsylvania. He served just one term from 1857 to 1861.

April 25, 1901: New York became the first state to require license plates on cars.

April 27, 1865 - On the Mississippi River, the worst steamship disaster in

U.S. History occurred as an explosion aboard the *Sultana* killing nearly 2,000 passengers, mostly Union soldiers who had been prisoners of war and were returning home.



UPDATE ON THE FOREVER BURNING LIGHT BULB aka "WATT-A-BULB"

In the October 2012 OIL Lantern, the Centennial Light (photo on the left) was identified as the world's longest-lasting light bulb. It is in use at 4550 East Avenue, Livermore, California, and maintained by the Livermore-Pleasanton Fire Department. At the time of the 2012 OIL Lantern article, the light has been burning continuously for 113 years. It is a hand blown bulb with a carbon filament which burns at 4 watts. It has been burning continuously in the firehouse as a nightlight over the fire trucks. The bulb was donated to the Fire Department in 1901 by Dennis Bernal who owned the Livermore Power & Light Co.


Now, it is 2023 and the bulb is still burning; so bump up the continuous in-service time to **124** years. Since modern bulbs are good for about 1,000 hours of burn time; this means the "Watt-A-Bulb" has outlasted almost 1,000 current day bulbs.

Many theories have been advanced to explain the bulb's longevity. They are: 1) Its perfect seal (which maintains the vacuum and keeps the filament from disintegrating), 2) Its low wattage (which keeps it from burning hot) and (3) That it is not subject to being turned on and off.

The OIL Lantern editor will report to the OILA membership in the year 2033 if the light (and of course, himself) is still in service. The editor hopes to report that both are still burning hot!.

REP. MATT GAETZ MEETS WITH OKALOOSA ISLAND LEASEHOLDERS' ASSOCIATION

Editor's Note: At the March 13, 2013 meeting of the Okaloosa Island Leaseholder's Association, **Congressman Matt Gaetz** addressed the membership and accepted questions from those in attendance and those on Zoom. Following is the article about this meeting which was extracted from Congressman Gaetz's online message site dated March 18, 2023.



Given Florida's First Congressional District is home to the country's largest military district and the stunning Emerald Coast, it is my responsibility as Congressman to represent Northwest Floridians accordingly. Monday night's meeting with the Okaloosa Island Leaseholders' Association allowed me to listen to Northwest Floridian's concerns.

I share the same concern many residents of Okaloosa County have about offshore Florida's Beauty and strategic training areas. In addition to blocking harmful Legislation, I introduced an amendment

to the Strategic Production Response Act that would maintain a 10-year prohibition on oil and gas leasing off the coast of Florida, which was adopted by the House of Representatives. I won't back legislation that uses a few barrels of oil as a justification to destroy our beautiful Northwest Florida beaches, and I refuse to harm critical mission test sites, like Eglin Air Force Base.

Additionally, members expressed their widespread concerns about the Biden Border Crisis, curbing federal spending, and the weaponization of the FBI. Okaloosa Island Property Owners: Are you aware of some of the current threats to both the value and the enjoyment of the property that you own on Okaloosa Island? • Replacing our durable four-lane, with-median Santa Rosa Blvd (SRB) with one mile of no-median, two-lane road and one mile of no-median, three-lane road. • Attacks on the Okaloosa Island Protective Covenants and Restrictions (also known as the "Covenants" or as the "PC&R's") which benefit all owners of property on the island. • Paving our northside freeways (the six natural habitat areas that drain storm water adjacent to the neighborhoods north of SRB) to add public parking. • Attacks on the prohibition of short-term rentals in the single-family neighborhoods north of Santa Rosa Blvd. The elected Okaloosa County Board of County Commissioners (BCC) has unanimously ignored testimony and polls about preserving all four lanes of Santa Rosa Blvd and is pursuing the project. Despite what the BCC is willing to accept regarding emergency response times, reducing four lanes to two lanes has serious public safety impacts – think of fire, medical, and lifeguard emergency responders whose responses will be delayed. Such delays could result in loss of life. Reducing lanes will result in more accidents and traffic back-ups from tourist buses, public transportation, delivery, trash, food and beverage trucks, etc., which will frustrate both tourists and locals. SRB is the only road for driving onto and off the island. Single-family homeowners wanted to keep the northside freeways natural and unpaved. Against their wishes and in violation of the Covenants, the Okaloosa County Board of County Commissioners paved one northside freeway. Result: This is now a public parking lot right next to residential homes. Update: The BCC recently discussed paving the remaining northside freeways. We, the property owners, are the little guys in these battles against big business interests and the Board of County Commissioners. Commissioner Boyles said, "Okaloosa Island is a fractured world" and that he sensed disunity among Islanders. He repeatedly advocates for changing our Covenants, abolishing the county's formal relationship with OILA, and paving our freeways. Sadly, the BCC continues to place its goals above our interests. When united against prior threats, property owners have prevailed. An example of this was the opposition to the proposed extension of Wright Parkway via a new bridge to the western end of Santa Rosa Blvd (to replace Brooks Bridge on Hwy 98) - this would have put Hwy 98 traffic on Santa Rosa Blvd. How



NEW BRIDGE CONSTRUCTION TRAFFIC ALERT

Starting on Wednesday, March 8, 2023, a portion of Brooks Street in downtown Fort Walton Beach was realigned and converted to **one-way traffic. According to the Florida** Department of Transportation, the <u>section of</u> <u>Brooks Street affected will be from Perry</u> Avenue to Florida Blanca Place, near the southeast entrance to Publix in the Shoppes at Paradise Point. The one-way direction will east to west, allowing traffic to flow into the downtown area. This configuration is expected to be in place while crews construct the new westbound bridge.
