





EDITOR'S NOTE: The above peel-off adhesive label (actual size) – WRIGHT IS WRONG! will be available to all at the April 13 OILA meeting and at the FDOT meeting on Thursday, April 23 at the Convention Center.

OILA POSITION. In short, No bridge to Okaloosa Island west of the current Brooks Bridge. The Association is on record as ... opposing any bridge connecting to Okaloosa Island from the Brooks Bridge westward to Navarre... The Association wrote a letter in October 2002 to the members of the Emerald Coast Bridge Authority (ECBA) informing them of our opposition to any bridge alignment which would connect Hwy 98 to Santa Rosa Blvd west of the Brooks Bridge. Also, we provide notices of meetings of the ECBA in the OIL Lantern and encourage members to attend their monthly meetings. Presently the ECBA has reduced the possible alignment of the bridge to three corridors – However, one of the remaining corridors, the Wright Parkway alignment, would connect a bridge from Hwy 98 to the west end of Santa Rosa Blvd. This alignment would turn Santa Rosa Blvd into a major traffic by pass loop off of Hwy 98



Details: The Florida Department of Transportation (FDOT), invites you to attend a public kick-off meeting concerning two bridge studies in Okaloosa County. The first study is a Project Development and Environment (PD&E) Study of State Road 30 (U.S. 98) over Santa Rosa Sound, also known as the Brooks Bridge Replacement Study. The intent of this study is to evaluate replacement alternatives for the existing Brooks Bridge. The second study, the Santa Rosa Sound Alternate Crossing Study, will evaluate a potential alternative crossing of Santa Rosa Sound. Both studies will be introduced at the same meeting.

A brief presentation will begin at 5:45 p.m. FDOT representatives will be available to discuss the projects, answer questions, and receive comments. Your attendance is encouraged and your participation and comments are appreciated.
