# THE GOOD OL' DAYS ON OKALOOSA ISLAND IN 1955

According to the "TODAY IN LOCAL HISTORY" article (see below) published in the September 29, 2015 edition of the Daily News, in 1955 (60 years ago) you could purchase a 100 foot lot on the Island at the following locations for these prices:

Facing the Gulf:	\$7,500
Island Interior:	\$2,500
Sound/Bay Side:	\$5,000

Also, one of the prizes in the seventh annual Destin deep-sea fishing rodeo (1955) was a 99year lease on a residential lot on Okaloosa Island.

The grand prize for the seventh annual Destin deep-sea fishing rodeo was a 1955 Chevrolet Sedan. The grand prize was to be awarded for largest catch in the king mackerel-red snapper competition. Other prizes included a 99-year lease on a residential lot on Santa Rosa Island in the Okaloosa Island Beaches development area, a five horsepower outboard motor and two \$50 savings bonds.

The Okaloosa Island Authority was considering raising prices of lots from \$50 a foot for lots facing the gulf to \$75, from \$15 to \$25 for interior lots and from \$35 to \$50 for sound or bay front lots.

It was suggested to her to report noise volume to the sheriff's office. Or the Coast Guard. OILA members should continue to voice opinions with the Chamber and the Sheriff's Department and to Representative Matt Gaetz.

#### New Business:

The drawing of the Conceptual Plan for Veteran's Park at Bayview was in the newsletter. Following a discussion Jim impson moved that OILA endorse the conceptual plan of June 2015 drawing and reserve the right to review future proposals. All in favor. Letter to be sent to Board of County Commissioners expressing our support.

Wednesday Night fireworks on the island have been enjoyed by residents and visitors. Tripp Tolbert and other businessmen contributed \$1000 weekly to this enjoyable event. Not everyone was as generous. A discussion ensued about the lack of property taxes being paid by Holiday Inn/Emerald Breeze.

Tripp Tolbert asked Maryl Bednar how could excess MSBU funds be used. She stressed that we keep \$100,000 in reserves, and that beautification is the allowable use under the ordinance. He suggested that the Beautification Committee devise a plan for the medians.... perhaps ask for matching funds from the condominiums and hotels... and put the excess fund to good use. Already serving on the Beautification Committee are Dave Miller, Kathy Foster, Carmen Parker, Cathy Taylor, and Kim Haines. Tripp Tolbert and Jim Hendricks volunteered to serve also.

Tripp Tolbert is on the Brooks Bridge Replacement Committee and Dave Hancock is an alternate.

Tripp suggested OILA become involved with the TDD who appears to be paralyzed. Tripp will unveil a new plan he has for his commercial property tying into Veteran's Park.

Are coyotes still on the island? Yes, but feral cats seem to have disappeared.

Adjournment: With no further business, the meeting was adjourned at 7:58 p.m.
