Okaloosa County **Sheriff Larry Ashley** spoke to the Leaseholders at the membership meeting on June 13. Due to a spike in recent shootings on the Island (one at the Green Frog and two at the Red Rose) there is a lot of concern about public safety. There were 10 shooting in Okaloosa County in 2015. **Sheriff Ashley** advised that the Red Rose incidents were still under investigation and pointed out that much of the violence is related to drugs and prostitution. He advised that the Red Rose was taking measures – metal detectors and staff being physically present full time inside the premises during business hours – as steps to mitigate the problems. He also noted that one of the main crime fighting tools is the immediate presence of law enforcement and went on to explain how the Sheriff's Office had just recovered the same funding level it had in 2007 when the budget was cut 20%. During the three years (2009 to 2012) following this cut he pointed out that violent crime increased 93%. Due to this cut, the Sheriff's Office had to cut personnel which reduced the number of deputies present and visible in the communities. As a matter of perspective, he pointed out that there were 10 homicides in Okaloosa County in 1998 and that crime in Okaloosa County has decreased by 13.7% from 2013 to 2014. The Leaseholders thank **Sheriff Ashley** for taking the time to talk to us.

More Than You Ever Wanted to Know About Flushing a Toilet

When we flush our toilets or run water in our shower most of us do not consider what it takes for this to occur. We pay our bills each month and do not stop to consider the amazing process of treatment of raw wastewater.

But first some good news: In the 5-year rate plan, rates remain fixed with no increase the first 2 years. For the final 3 years, rates increase 2.5 percent per year. This rate plan is well below even modest increases, for several reasons. Normally we would have above 3. 5 percent rate increase each year. Yet, thanks to a win-win partnership with other entities like Eglin Air Force Base and the City of Fort Walton Beach, revenue has increased. All in all, 6 aging wastewater treatment plants (without nutrient removal) have been decommissioned, and Okaloosa County now provides wastewater treatment to the following areas at the state-of-the-art Arbennie Pritchett Water Reclamation Facility: County services areas, City of Fort Walton Beach service area, Eglin Main Base, 7th Special Forces Group, Duke Field, and Camp Rudder. These partnerships have produced both environmental and financial benefits.

In addition, the County has received approximately **\$7.5 million in grants** and appropriations over the past few years. This funding will be spent on major capital projects, where otherwise, higher rate increases would have been sought to pay for those projects. Examples of these grant-funded projects include: new water mains and hydrants in a neighborhood, new water supply main to Okaloosa Island, rehabilitation of the sewer system, a new water tank, and a reclaimed water project.

I recently made time to visit the Arbennie Pritchett Water Reclamation Facility. I wanted to share with you what I discovered. The **Arbennie Pritchett Water Reclamation Facility** (APWRF) was commissioned in 2009 to replace the old and outdated Garniers WRF. The APWRF is known as a conventional 4-stage activated sludge facility with a current permitted capacity of *10 Million Gallon per day* (*MGD*). Current average *daily flows* (*ADF*) through the facility are 7 MGD. The APWRF consists of pretreatment, biological process, *ultraviolet disinfection* (*UV*), Rapid infiltration basins (RIB's) for effluent disposal, reuse water for irrigation and bio-solids dewatering and removal.

Raw wastewater entering in to the APWRF contains extreme amount of organic and inorganic material (garbage and grit). The inorganic material must be removed before entering the biological process. This is achieved by pretreatment. Pretreatment is the headworks of the APWRF and consist of screening and grit removal to take out the inorganics.


The nutrient (organics) rich wastewater is then applied to the biological process where high volumes of aquatic micro-organisms (AMO's) feed on and 'break down' the organics, removing ammonia and nitrates, which are major pollutants of the environment. This is accomplished in two 2.34 million gallon (MG) tanks commonly known as oxidation ditches. The oxidation ditches are designed and engineered to provide an ideal environment for the biological mass of AMO's to thrive and reproduce. This process allows the biological mass to separate and settle by natural gravity. The settled bio-mass is recycled back to a filtration system, chlorinated to high level disinfection, and then to the Fort Walton Beach Golf Course for irrigation purposes only.

A by-product of the process is known as bio-solids. This excess must be strategically removed to keep a constant balance of AMO's in the system. There the thickened bio-mass is stored and eventually dewatered with a device known as a centrifuge which produces a dewatered product labeled Class B bio-solids. This class B bio-solids is transported to farmland in parts of northwest Florida and south Alabama and used for soil remediation and fertilizer.

The **Russell Stephenson WRF** (RSWRF) was commissioned in 1992 to serve the southwest area of Okaloosa County from Hurlburt Field on Highway 98 to the Okaloosa/Santa Rosa county line. The RSWRF is known as a conventional 2 stage activated sludge facility and has a permitted capacity of 1 MGD. Current ADF through the facility is approx. 450,000 gallons/day. It is similar in design to the APWRF. The RSWRF has pretreatment, oxidations ditches and clarifiers. Bio-solids produced at the RSWRF are transported in liquid form to the APWRF's digester. **Joe Jones** is responsible for the impressive operation of this older facility and his work to maintain the facility in immaculate condition.

We thank **Jeff Littrell**, Director of the Okaloosa County Water and Sewer System. He was recently recognized for 20 years of service with Okaloosa County. We also thank **Mark Wise**, Deputy Director and **Darren Alford**, Wastewater Operations Manager and the many employees who work with the Water and Sewer Department to make this process possible so that we properly treat wastewater and maintain a sustainable environment.

Bike path is an idea whose time has come

Some ideas make so much sense you wonder why they weren't thought of before. That was our reaction to the news Okaloosa County is looking at a bike path on Okaloosa Island from Brooks Bridge to Marler Bridge in Destin.

To recap, Daily News staff writer Kari Barlow reported on June 9 the Okaloosa County Commission voted to spend \$102,000 on preliminary design plans and an environmental assessment of a bicycle path that would be detached from U.S. Highway 98 and run the length of Okaloosa Island between the two bridges. Such a path would require the approval of Eglin Air Force Base, the National Park Service and the Florida Department of Transportation.

It goes without saying there's a reason U.S. Highway 98 is called "Bloody 98." The stretch between Gulf Breeze and South Walton is notorious for its carnage, both vehicular and pedestrian. People on foot or riding bicycles take their lives in their hands when they navigate 98, and the result is often fatal. Just a month ago the Daily News reported on the toll claimed by that road over the past year. In seven instances pedestrians or bicyclists were either killed or injured.

That's partly due to the lack of sidewalks or bicycle paths. As it stands now, bicyclists on Okaloosa Island are allotted a thin ribbon of asphalt on the edge of the highway. Even if drivers are paying perfect attention, that's still a dicey proposition. An ill-timed gust of wind could result in a bicyclist's death, never mind the drivers who are talking on their phones or worse, texting.

The county's plan calls for a detached path running along the north side of U.S. 98, which would take walkers and bicyclists out of harm's way. Finally, a way to make Bloody 98 a little less bloody. Another benefit: The recreational opportunities such a path might offer boggle the mind. When the City of Fort Walton Beach built its Fitness Trail at Ferry Park an instant demand was created for safe places to walk. A bike path would create a similar demand and might even lead to the creation of new businesses and cut down on traffic congestion.

We hope all parties sign off on the proposed path so that one day, it becomes safe to walk or ride a bicycle on Okaloosa Island.

INFORMATION ABOUT ZIKA FEVER

Zika fever is a mild febrile illness caused by a mosquito-borne virus similar to those that cause dengue and West Nile virus infection. It has been identified in several countries in Central and South America, Mexico, and the Caribbean since 2015. Outbreaks have previously been reported in Africa, Southeast

Asia, and The Pacific Islands. Local transmission has been reported in Puerto Rico, but not elsewhere in the United States. Cases of Zika fever have been reported in travelers returning to the United States.

UPDATE: July 29, 2016: Four individuals in Miami-Dade and Broward counties have been infected with the Zika virus by local mosquitoes, Florida health officials said Friday. These are the first known cases of the virus being transmitted by mosquitoes in the continental United States.

Zika fever is acquired through the bite of an infected mosquito, including the same mosquitoes that can transmit dengue and chikungunya. Perinatal and sexual transmission have also been reported.

Only about 1 in 5 people infected with Zika virus are symptomatic. Zika fever is a mild illness. Severe disease requiring hospitalization is uncommon. Signs and symptoms of Zika fever may include: acute onset of low-grade fever, rash, joint pain, conjunctivitis (reddening of eye), body aches, headache, eye pain, and vomiting. Treatment is symptomatic since there is no specific treatment against the virus. Illness typically resolves within a week.


The Ministry of Health of Brazil has reported an increase in the numbers of newborns with microcephaly in areas experiencing Zika virus outbreaks. Further studies are being conducted to investigate this concern. There are many causes of microcephaly in babies, including genetic abnormalities, environmental factors, and some infections acquired during pregnancy.


