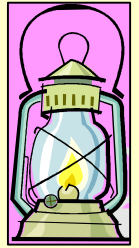

## MESSAGE FROM THE PRESIDENT – David Hancock

Late last week had confirmation from Okaloosa County's Tourist Development Council that they have budgeted funds for a new beach access way facility; this budget takes effect in the fall of 2017 so it's not far away! OILA still has to be vigilant as these budgets have to be blessed by the TDC board of directors and the Okaloosa County Commissioners.

A lot of great work is ongoing by OILA's beautification committee members to make Okaloosa Island a preferred place to visit and live. Kathy Foster and John Dowd are aggressively pursuing derelict property owners by activities including legal action. Kim Haines has materials on hand for the Santa Rosa Boulevard Banners. Cannot wait for these to go up. Hope that as many as possible will turn out to help put these up.

The beach sand workshop took place April 25 with 10+ members in attendance. The event was primarily the report by the attorney Matthew Leopold who was hired by the Okaloosa county commissioners to review the work done so far by the to find the best sand for our beach. Here are some highlights:

- The application process by Okaloosa County to the Corps of Engineers for the emergency restoration permit is still moving forward. This effort is critical as it will let Okaloosa County act promptly to repair storm damage.
- Okaloosa Island beaches have recovered from their post hurricane Ivan low point through ecretion (I learned a new word – wave action depositing sand on the beach). However, the beaches must be looked at as a system encompassing the not only the beach but also dunes and offshore sand bars. From the system perspective Okaloosa Island has lost hundreds of thousand of cubic yards that will never be recovered naturally.
- The flow of sand in the gulf is East to West. Eglin AFB base did a beach restoration back in 2010 and this sand is moving to Okaloosa Island beaches and also polished by wave action in the process.
- One of Mr. Leopold's recommendations was to consider restoring offshore sand bars. Natural wave action will push this sand to the beach and also polish it. I personally like this idea. This sand workshop was primarily a review and learning event for the county commissioners. No actions were taken. **However in May – do not have the date will let everyone know when available – a presentation is being planned for the Okaloosa Commissioners which builds on Mr. Leopold's work and make recommendations for action by the commissioners.** Please plan to attend that.

Moving the no wake sign to the west in Santa Rosa Sound is still moving forward. Attending the Fort Walton Beach City Council meeting May 9 to ask the city to pass a resolution supporting this effort.

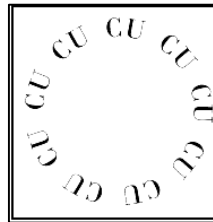

The sealed lithium battery does not need replacement and the device complies with all the major underwriters and authorities for early warning detection and alerting. Please stop by the Okaloosa Island Fire District to obtain your free alarm(s) for your home. Please understand that we have a limited supply and the Red Cross will replenish our stock as we give them out. For your convenience a copy of the **Red Cross Service Acknowledgment Form** is attached to this newsletter. In order to save time, if you are receiving this newsletter by email, you can download and print this form then complete as much of the top part (outlined in **orange**) as best you can and bring it with you to the Fire Station. Also, the forms are available at the Fire Station and you can complete them there.

If we are out of alarms we will use your Service Acknowledgment Form as a back order “rain check” and will notify you when additional units come in.

You may have seen some of our committee members with paint spray cans along the boulevard. No, they are not ‘tagging’ just refreshing the stained pump covers. Thank you to John Dowd, Bob Haines and Kathy Foster

The legal action against property owners on Tropic Avenue was not taken lightly. Since July 2013 neighbors, Code Enforcement and county officials have attempted to work with the owners. For four years junk and trash (plastic gloves, empty bleach bottles, food, etc.) has accumulated. On April 26, 2017 the case was filed requesting a summary judgment.

**Boat Basin - Carol Edlund:** No report.

**Website – Bob Seitz:** Bob advised that he received an inquiry about OILA’s position on a permit from the Gulf restaurant to build 15 to 20 docks on the Sound Side of their property which will require an expansion of the current minimum wake zone. Bob said he advised the inquirer that the Leaseholders favor extending the minimum wake zone all the way to Marler Park which means that the zone change requested by The Gulf would be covered within the parameters of our recommendation

**Beautification/Derelict Property Committee – Kathy Foster:** Kathy reported that legal papers had been sent to the property owners on Tropic Drive and that they had 20 days to respond. She also advised that Okaloosa County Growth Management had sent out a team to survey and mark property lines. Anything on the Tropic property which were encroaching on County property would have to be moved off. Kathy noted that the Street Pole banners looked good and that the new owners of 639 Pompano had made major improvements – landscaping, new fence.

**OLD BUSINESS:**

**A. Minimum Wake Zone – Dave Hancock:** Dave was out of town and Paula Hudson gave the report. Paula advised that there was nothing new to report on the process at this time.

**B. Street Pole Banners – Kim Haines:** Kim advised that the Fire Department has volunteered to mount the banners; however, they will have to wait to do so until their ladder fire truck comes back. It is presently under going a major refurbishment in Appleton, Wisconsin. Chief Tilley hopes to get it back around April 25. Kim also advised that the banners will be mounted individually; not in pairs. Each banner is double printed on both side. This approach will give more coverage (20 pole mounts instead of 10). She also advised that the banner has to be 12 feet off the ground. Also, there was discussion about being self sufficient in running the banner (and other) program – having the ability to take up, take down, storage of equipment (ladders), supplies, etc.

**C: Public Information Meeting on Pending Changes in Flood Zone Map – Jim Simpson:** Jim advised that their will be a town hall meeting on the subject of interpreting and understanding the proposed changes in the pending new flood zone map. The meeting is scheduled for Monday, April 24 at 6:00 pm. The location will be announced by Commissioner Ketchel following the Tuesday (April 11) night Commission meeting. It will either be at the Convention Center or the Shalimar Office complex. Jim Simpson advised that he would send out an email blast when the location is determined.

**NEW BUSINESS:**

**A. Appointment of a Nominating Committee to make Recommendation for 3 Board Members whose terms expire in June 2017 – Dave Hancock:** On behalf of Dave Hancock, Vice President Lynn Dominique advised that the President had selected a 5 member nominating committee as follows: Paula Hudson, Desley Parker, Donald Horwell, Dave Hancock and Jim Hendricks. Presently 3 members on the board have terms which expire in June 2017

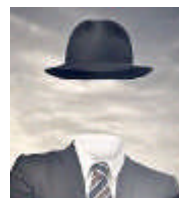
