#### MESSAGE FROM THE VICE-PRESIDENT – DAVE MILLER


It has been a number of years since I wrote an article for the OILA Lantern.

It's springtime once again. Time for pruning and planting. Since I live in a condo, I don't have to worry about doing much at my place (although I have used a saw car to trim some bushes by our gazebo).

When I run the cul de sac side streets I notice a lot of bushes and trees that encroach over the roadway and even block mail boxes. As far as the mail boxes, I wonder why the post man delivers to some houses. Generally, there is only one car on the streets at a time so I guess most people just drive down the middle of the street and avoid the low tree limbs and growth into the roadway.

For my part, I do have a bow saw and hedge trimmer in the trunk of my car. Periodically I go down Santa Rosa Boulevard with the bow saw and cut back anything that is over the sidewalk (several other people do this as a community service to the Island). The OILA derelict property committee has worked over the years to get individual owners to take care of their property. It all helps Okaloosa Island look better for us all.

#### VIII. NEW BUSINESS

Point of Order: Paula Hudson objected to voting on these items since there were individuals present whose membership qualifications had been not veriifed with a check of the Okaloosa County Property Assessor's records Her objection was noted.

A, Proposed OILA Letter to the Board of County Commissioners to Begin Beach Restoration on Okaloosa Island Beaches as Soon as is Practical. – **Tripp Tolbert:** Tripp motioned that this proposed letter be withdrawn from consideration as an item of business. His motion was seconded and carried.

B. Proposed Resolution: Request that Commissioner Ketchel to set up a public work shop on the issue of Okaloosa Island beaches – **Dave Hancock:** Motion to approve was made and seconded but the resolution did not carry..

C. Proposed Resolution: That in the event that a beach renourishment or restoration is proposed for Okaloosa Island monuments R-1 through R-15 or included, that the only acceptable sand source is the East Pass ebb shoal, the East Pass channel, or better- **.John Donovan:** Motion to approve was made and seconded. Resolution carried.

D. Proposed Resolution: That Okaloosa County be requested to re-open & re-write the East Pass Inlet Management Plan, with the Technical Advisory Committee being evenly balanced in its composition, between representatives of Okaloosa Island and representatives of Okaloosa County beaches east of the East Pass. Be it further resolved that the re-written East Pass Inlet Management Plan shall reflect the predominant east to west net sand transport, including a requirement in the implementation plan for sand placement to the west of East Pass – John Donovan: Motion made to approve was made and seconded. Resolution carried.

Tripp Tolbert advised that the Secretary will prepare a letter which will be sent to the Board of County Commissioners advising them of the two approved resolutions.

#### **IX. OTHER BUSINESS:**

President Tripp Tolbert annonced that he was resigning his position as President of the Okaloosa Island Leaseholders Association effective immediately. He advised that he would remain an OILA member.

Nancy Hunt requested funds to be approved for purchase of some new street banner hardware and labor (bucket truck operator) to repair street pole banners which need to be fixed. A motion was made, seconded and approved for her to proceed as needed. She also asked for a volunteer to agree to keep track of the street banner program – repairs and monitoring.

X. ADJOURNMENT: Meeting was adjourned at 8:45 pm.




