It was also very informative to learn about all the studies and projects in progress to provide pertinent information to Okaloosa County Commissioners for decision making. Was obvious that lots of things are going on to make the island a better place to live and visit; OILA needs to continue support of theses efforts as they are in our best interest.

Thanks to all members who attended the boat basin meeting and the US Army Corps of Engineers workshop in December. By having a good OILA turnout at these events we will continue to be in the loop on decision making by Okaloosa County concerning the island.



## **MEETING OF THE TREE COMMITTEE REPORT on November 28, 2018**

Attendees-Paula Hudson, Dave Hancock, Kathy Foster, Connie Dunlap, Carmen Parker, Beth Jetter and Dean Hanson.

After reviewing the plat drawings, with marking for existing trees and bushes, it was determined that the following items would be requested from the county.

- 1. Curbing
- 2. Lighting for trees along with electrical outlets
- 3. Trees-Suggested cabbage palms, bottlebrush and crape myrtles (large weepers)
- 4. Ask if lanes head west can be adjusted to make room for a wider bike path/multi-use path/sidewalk
- 5. Possible shortening of medians to add turn lanes

We assumed that the crosswalks will be upgraded per prior communication with the county.

4. Bridge to Bridge-AF has okayed, 1st draft of drawing are complete and funding has been identified.

- 5. Veterans Park-walking path to be installed around park and TDD will finance the veteran statues,

- 8. Beach Sand-There are currently 3 studies being conducted at this time, they asked that we be patient till they are completed.
