

## **OKALOOSA ISLAND LEASEHOLDERS PRESIDENT'S REPORT – DAVID HANCOCK**

At our March 11 leaseholders meeting Okaloosa County Chief of Beach Safety Mr. Rich Hufnagel will be the guest speaker. He will give a presentation and then take questions from our members on the Lifeguard situation on Okaloosa Island beaches. Many members have expressed concerns about this subject and it is especially pertinent now as the spring break is upon us. Hope everyone who has concerns or question will be there March 11.

February 25 was a big day for the Leaseholders Bridge to Bridge pathway proposal – the Okaloosa County TDC approved UNANIMOUSLY a request by Jason Autrey Okaloosa County Public Works Chief to fund the definitive environmental study required by Eglin AFB for their final approval of the Bridge to Bridge Pathway. This definitive environmental study is part of the Eglin process and has to be done. **Even more significant is the pledge by Mr. Jay Odom of \$100,000 for construction of the Bridge to Bridge Pathway.** Events like this build momentum for the Bridge to Bridge Pathway. We are especially in debt to Mr. Jay Odom for his pledge – hope everyone will express their thanks.

Floating structures in Santa Rosa Sound have been a persistent nuisance in Santa Rosa Sound since Crab Island has become a vacation hot spot. These floating structure are not boats but floating vendor stands anchored all over the sound and have no running lights so they are downright dangerous. After discussing with Okaloosa County a solution has been found – Captain David Allen of the Okaloosa County Sheriff's has stepped up to tow these offending structures. Captain Allen has command of Okaloosa County's Marine Unit. His authority comes from the Okaloosa County Ordinance 18-19 which was passed by the Okaloosa Commissioners in 2018. Note that this ordinance was brought to our attention by two OILA members who had enough of the crab island overflow. Thanks to them for their diligence.

At the March 19 Okaloosa County Commission Meeting the proposed beach vendor ordinance was discussed and passed. Lots of OILA members showed up and we came away with a victory on one point and a defeat on another:

- First the victory the proposal for beach rangers to enforce vendor rules was replaced by using deputy sheriffs for this role. The deputy's will be off duty and paid off duty job rates. Commissioner Graham Fountain had a great comment "a badge and a gun gets it done".
- Now for the defeat and this was a heartbreaker the present procedures of letting beach vendors put chairs and umbrellas edge to edge of the borders of the upland property will remain. Note that every OILA member has spoken against this. Okaloosa Island is public beach but when the vendors are allowed to put chairs border to border the beach is effectively PRIVATIZED. Putting it another way the beach vendors deprive everyone of the use of public property. Either way this is not right!

Another change is that beach vendors are now required to rent their chairs to the public and just beach property guests but the cost will be what these guests are charged which may not be a bargain. Remember what Jason Autrey said at the last OILA meeting – Okaloosa island is public beach so the vendors cannot stop anyone from putting chairs and umbrellas anywhere. The president of the Island Breeze Condo association (they win the best condo Christmas decoration award every year) coined a great phrase – Ghost Chairs. This is the empty chairs vendors put out tying up the beach front from edge to edge. Suggest everyone takes lots of Ghost Chairs photos this spring and summer and forward to the BCC.

In the March newsletter there is a proposed design for the Boat Basin improvements at thr Sound-side of Beach Access way Number 2. Note that the is a proposed design; the proposed design is shown in this newsletter. One of our long serving leaseholder members has issues with the placement of the parking lot in the proposed improvements as this space may quickly become overflow parking when the beachside spaces are full and I have to agree with her. Lots of traffic and congestion for a small space will be the result. The best method may be using beach access way 2 on the sound side as a drop off point and use only the beach side of 98 beach access ways for parking. There is a lot of parking on Santa Rosa Boulevard with the opening of the new beach access way facilities. I hope all interested OILA members will provide an opinion to Okaloosa County.



Announcements: County Commissioners Meeting Feb 19th 8:30 Public Hearing on proposed Beach Vendor Ordinance TDC Meeting Feb 26th 9:00 Okaloosa County Administration Building Funding request for Econ Study for Bridge to Bridge Pathway

**Speaker: Greg Kisela**, Assistant Administrator for Okaloosa County and Jason Autrey, Director of Public Works. 1. Crosswalks are in the 1st round of projects to be completed. Design has not been completed yet. 2. Revised Beach Vendor Ordinance. The county is attempting to strike a balance between vendors and the general public using the public beaches on Okaloosa Island. They are hopeful that changes will take effect this season. Some of the changes are: -No setups of ANY kind prior to 7:30 to allow for beach cleaning and turtle nest checking, to be enforced not a new ordinance. -Any vendor chairs and umbrella must be made available to the general public at the going rate. They can not ask the public to move any private chairs or umbrellas -Increase vendor fees: \$500 for permit, \$500 for each beach vehicle and \$10 for each unit in the resort the vendor is contracted with. -Implement 2 full time seasonal beach rangers to assist in compliance with vendor ordinance and dogs -All wedding vendors will be required to obtain a \$100 permit and will be able to use public beaches for a 3 hour window; 1 hour prior to 2 hours after sunset. Current ordinance does not allow them to use the public accessway. -Vendor Discipline; 1st offence, written notice and a \$500 fee. 2nd offence, permit lost for season. The county reserves the right to revoke a permit at any time

Discussion followed the presentation with mixed opinions on the vendors making money on the public beaches, the perception the vendors are giving that the beaches are private, chair placement, dogs, noise and the need to provide chairs and umbrellas for our visitors



### DO THE PROTECTIVE COVENANTS AND RESTRICTIONS APPLY TO PROPERTIES OWNED BY FEE SIMPLE TITLE?

The above question has been asked in the context of properties that have been converted from lease to fee simple title. The answer to the question is "Yes, the protective covenants and restrictions are valid for properties held by simple fee title." The following language, which is quoted from the fee simple title document, reimposes the protective covenants and restrictions.

IT IS THE EXPRESS intent of the grantor that its reversionary estate in that portion of the original leasehold estate from the Okaloosa County and/or Okaloosa Island Authority which the grantee now owns in the subject premises shall be merged with such present leasehold interest now owned by the grantee, subject, however, to such terms and conditions contained in the 1963 quitclaim deed of record from the United States of American to the grantor and all protective covenants previously imposed of record on the above land by Okaloosa County or its agent, Okaloosa Island Authority, and by acceptance of this deed, grantee acknowledges the validity of such protective covenants and restrictions (with the term "owner" being substituted for
