# **MESSAGE FROM THE PRESIDENT – David Sherry**

Thank you to everyone who put Christmas decorations on their home or who helped with OILA's welcome triangle and median Christmas decorations. A special thanks goes to Nancy Hunt for leading OILA's efforts, and for gathering an impressive list of prizes for winning homeowners.



And thank you to all who donated to OILA's food drive. Thanks to your donations, we collected a record 255 pounds of food to help those in need.

On January 21, starting at 2:00 PM, the Okaloosa County Commissioners (BCC) will hold two public hearings of interest to Okaloosa Islanders. The BCC meeting starts at 1:30 PM in the county administration building in Shalimar, but the public hearings portion of the meeting will not begin until 2:00 PM.

One public hearing will be to adopt changes to the beach vendor ordinance regulating activity on the beaches of Okaloosa Island, and placement of personal property on the beach. Although the November 12 public workshop on this ordinance appeared productive and inclusive, provisions seemingly favored by the public and commissioners (such as a sliding fee scale for vendors based on usage and enforcement enhancements) were not incorporated into the latest (December 17) published version. In addition, language in the existing ordinance that protects the public's right to engage in fishing and other activities before 7:30 AM from the beach has been eliminated. If these issues are important to you, please consider writing the Commissioners and/or attending the public hearing to make your opinion known.

The other public hearing will be to adopt a single family home short-term rental ordinance. Per the November 12 public workshop draft minutes the new ordinance will not supersede restrictions contained in the Okaloosa Island Protective Covenants, but anything can happen at a public hearing, so anyone concerned about upholding the Covenant's restrictions should consider writing the Commissioners and/or attending the public hearing.

The 7:00 PM February 10 OILA meeting will feature Crime Prevention Specialist Ashley Bailey and Sergeant Brian Perkins, both with the Okaloosa County Sheriff's Office (OCSO). They will address crime and vagrancy on Okaloosa Island, and include suggestions on what you can do to be safe and how and when to report incidents and concerns to OCSO.


# **OKALOOSA ISLAND: FRIENDS AND NEIGHBORS**

**III. MINUTES:** Secretary John Donovan made a motion, seconded by Rick Deckert, to approve the draft November 11, 2019 minutes with a correction of any misspelled names. Motion was approved.

## VI. UNFINISHED AND NEW BUSINESS:

1. President David Sherry started a discussion regarding an Okaloosa County public workshop to address short-term rentals in single family homes and duplexes scheduled for 1:30 PM tomorrow in the county administration building in Shalimar. He stated this would be a new county ordinance. The agenda packet published that contains the draft ordinance is unclear whether restrictions in the Okaloosa Island Protective Covenants will supercede the proposed county ordinance. In response to a condominium owner concern, Rebecca Sherry clarified the ordinance does not impact condominiums. Treasurer Jim Simpson asked if President Sherry would like an e-mail blast to be sent on this issue to the members, and David said yes.

VII. ANNOUNCEMENTS: Director Dr. David Miller asked if Okaloosa County still plans to rehab the beach accesses. He said the roof of Beach Access 7 was rusted through, several access buildings needed a thorough cleaning, and new stainless steel handrails are rusty. Director Kathy Foster offered to write a letter to Commissioner Carolyn Ketchel and report back to the membership. Mary Muller inquired about new survey stakes on the bayside at Beach Access 3. Lylee Dodson reported on a crime incident. After a discussion and with member consensus, President David Sherry said he would invite Ashley Bailey, Crime Prevention Specialist for the Okaloosa County Sheriff's Department, to speak at a future meeting. Treasurer Jim Simpson recognized new member Theresa Sampson.

**VIII. ADJOURNMENT:** The meeting was adjourned at **7:52** PM (motion by Rebecca Sherry, seconded by Director Dr. David Miller and passed).
